


End to End Dividend Compliance Management

Vide Finance Act 2020 the Indian government, has abolished Dividend Distribution Tax. Thus there was change in dividend taxation regime from being tax on company to a tax on shareholder. It has led to significant increase in compliance requirement for companies having large shareholder base, since TDS liability is computed based on category of the shareholder as well as their tax residential status, manually determining appropriate TDS rate for large shareholder base is challenging and time consuming.

Use of technology becomes imperative for such time sensitive and process driven compliances to provide enhanced comfort on accuracy and build efficiency in the process.


Auto Bulk Form 15CA & 15CB

An entity/person responsible for making a payment to a non-resident or to a foreign company has to comply with Form 15CA & 15CB provisions subject to specified exemption list.
